The undersigned, in consideration of Renting the Tonopah Memorial Swimming Pool and related facilities for a Private Party hereby agree to the following:

1. I agree to pay the sum of \$50.00 for rental of the Tonopah Memorial Swimming pool and facilities. I understand that pool rentals are limited to Wednesdays, Fridays and Saturdays between the hours of 6:00 p.m. and 9:00 p.m. and is contingent upon availability of lifeguards and weather. In the event staffing or weather prevent renting the Pool and facilities on the date requested, I understand that I may reschedule or request a refund from the Town of Tonopah.
2. I further agree to pay a \$30.00 Security/Cleaning deposit. This deposit shall be refunded to me by the Town after the Pool Supervisor has deemed that the pool and facilities were left in the same condition as prior to the rental. I understand that if the pool and facilities are not cleaned at the end of the rental, that I shall forfeit the cleaning deposit to the Town of Tonopah.
3. I understand, should any damage occur to the Tonopah Memorial Pool or facilities that I am liable for the costs to repair the damage. Costs shall include labor, equipment and materials required to fully repair damages.
4. I agree that all parties in attendance during the rental shall follow all of the rules as directed by state and local regulations and the Tonopah Memorial Pool. I understand that should anyone in my party violate the rules and regulations, they may be asked to leave the premises. (See Pool Rules attached).
5. I agree that all persons using the pool and facilities during the rental period shall vacate the premises on or before 9:00 p.m. Failure to vacate the premises by 9:00 p.m. will result in forfeiture of my Security/Cleaning Deposit and may result in the parties being trespassed from the property.

**I hereby agree to hold harmless the County of Nye, the Town of Tonopah, and Tonopah Memorial Swimming Pool free and clean of any and all claims of any nature or kind whatsoever for injuries and/or deaths incurred during use of the premises, and to indemnify Nye County, the Town of Tonopah and Tonopah Memorial Swimming Pool for any expense incurred defending any action or actions arising out of such injuries or deaths. I assume complete responsibility during the rental period for said premises.**
