### MEETING MINUTES

JULY 10, 2013

Tonopah Town Board Chairman Horace Carlyle called the meeting to order at 7:04 pm. Also present were Javier Gonzalez and Ron Kipp. There were five other people in attendance.

Duane Downing arrived at 7:39 p.m.

### 1. Public Comment

Robert "Shane" O'Donnell commented on an issue with dust around his house. Mr. O'Donnell stated that construction debris that should have gone to the Nye County Landfill was placed on a residential lot across from his property. Mr. O'Donnell stated that dirt has also been dumped on this lot without proper watering to control the dust. Mr. O'Donnell also stated that he feels there is a natural spring or possibly a leak from the Town water system under the lot.

Chad Cobb stated he has the same complaint that Mr. O'Donnell has. Mr. Cobb questioned if there were Town Ordinances to address these issues. Mr. Cobb stated he was pretty sure there was a County Ordinance. Mr. Cobb also stated that he felt the water source was from a natural spring. He was told that the Town has checked on several occasions for a leak and was unable to locate a leak. Mr. Cobb stated he was also told the water was tested, the test showed no chlorine levels, therefore, in his opinion, it is obvious the source is from a natural spring.

Mr. Eason, Town Manager gave an update from Shaw Engineering Phase II and Phase III of the Water Project and preliminary drawings are available review. Mr. Carlyle asked about the rock. Mr. Eason responded the cost of the rock is estimated by the engineers to be 4.1 million.

The final payment for Phase I is pending approval later on this agenda.

Mr. Eason reported on his involvement regarding the public comment. Mr. Eason received a call regarding the public comment and has passed this on the Nye County Road Department. Mr. Eason spoke with Joe Westerlund regarding the water on the property. The water was tested and no chlorine was found. The water was tested in the past and leak detection was done as well. The Town has not found a leak at this time. Mr. Eason stated this does not mean it is a spring and it does not mean there is or is not a leak; it means the Town does not know. There is no excessive water loss from the Town. Mr. Eason has researched and has not been able to find any mention of a natural spring in that area. Some of the pipe that was dumped on the property was removed by the Town and taken to the landfill. There is not a Town Ordinance addressing dust control. The only Nye County Ordinance regarding dust control applies to the Pahrump Regional Planning Area.
