TONOPAH TOWN BOARD MEETING MINUTES

SEPTEMBER 25, 2013

Tonopah Town Board Chairman Horace Carlyle called the meeting to order at 7:01 p.m. Also present was Ron Kipp, Janet Hatch and Duane Downing. Harvey Gonzalez was absent. There were two other people in attendance.

1. Public Comment

Janet Hatch stated Chuck Watson wanted to thank the board for their direction regarding watering of the trees at and around the Senior Center. Mr. Watson wanted to find out what entity was responsible for the care and maintenance of the trees at the Senior Center and was advised to contact Joni Eastley, Nye County Assistant County Manager. Mrs. Hatch also stated that Mr. Watson was quite satisfied with the response from the County and Mrs. Eastley in particular.

2. Review and approval of minutes, in context, from the regular meeting held on September 11, 2013.

Duane Downing motioned to approve the minutes, in context, from the regular meeting held on September 11, 2013. Ron Kipp seconded. No further discussion. Motion carried 4-0.

3. Review, discussion, and possible decision and approval of Agreement between JNJ Engineering Construction, Inc., and the Town of Tonopah for Construction of Tonopah Public Utilities Phase 2 Transmission Main Arsenic Mitigation Project in the amount of \$3,664,450 which amount will be funded by USDA RD Loan and Grants and State Revolving Loan Principal Forgiveness Loan.

Duane Downing motioned to approve agreement between JNJ Engineering Construction, Inc., and the Town of Tonopah for Construction of Tonopah Public Utilities Phase 2 Transmission Main Arsenic Mitigation Project in the amount of \$3,664,450, which amount will be funded by USDA RD Loan and Grants and State Revolving Loan Principal Forgiveness Loan. Janet Hatch seconded. No further discussion. Motion carried 4-0.

4. Review, discussion, deliberation and possible action regarding Proposal received from Garland Company, Inc., in connection with Old Firehouse Roof Replacement and other possible improvements to the building.

Town Manager, James Eason reviewed the Proposal submitted by the Garland Company to replace the roof and other possible improvements.

Ron Kipp motioned to accept the proposal submitted by the Garland Company in connection with the Old Firehouse Roof Replacement and other possible improvements, not to exceed \$220,788. Janet Hatch seconded. Discussion: Mr. Eason advised the board that although in the proposal the "Total Maximum Price of Line Items under the MICPA reflects \$220,788; the Garland Company has assured him the cost will not exceed the "Proposal Price Base upon Market Experience" of \$188,446. Mr. Kipp asked if he needed to amend his motion to reflect the correct price. Mr. Eason responded no because in Mr. Kipp's motion the amount not to exceed will be greater than the actual cost. Janet Hatch seconded the motion. No further discussion. Motion carried 4-0.

5. Review, discussion, deliberation and possible action regarding Proposal received from Garland Company, Inc., in connection with scheduled maintenance to the Tonopah Historic Mining Park — Gift Shop roof and other possible improvements to the building.

Mr. Eason again reviewed the proposal submitted by the Garland Company and asked if the board had any questions.

Ron Kipp motioned to accept the proposal submitted by the Garland Company, in connection with scheduled maintenance to the Tonopah Historic Mining Park Gift Shop roof and other possible improvements to the building. Duane Downing seconded. No further discussion. Motion carried 4-0.

The Town Board recessed to the Tonopah Library Board of Trustees at 7:15 p.m. and reconvened to the Tonopah Town Board at 7:19.

Mr. Eason informed the board of his attendance at the NACO and Nevada Leagues of Cities Conference. Mr. Eason stated the Nevada Leagues of Cities has extended an invitation to the Town of Tonopah to join the league.

Ron Kipp asked if the Town is still looking into resurfacing the pool in the near future. Mr. Eason stated that the Town is looking into having the pool resurfaced. Mr. Eason stated that one of the problems with the resurface project is scheduling. The ideal time to resurface the pool is late Spring to early Summer which would require the pool to be closed for a period of time at the beginning of the season. Mr. Eason reported the Town is still looking into the details of what is entailed to complete this project but he will pass information along to the board as it becomes available.
