Since your last meeting:

- The Project Coordinator's position is now vacant. We are updating the job description and the
 position requirements and anticipate advertising the opening within the next two weeks. In the
 meantime, board members have divided up the responsibilities so business is uninterrupted.
- We have two new board members: Tracy McCormick, who is chairing our Promotions
 Committee, and Fawn Davila, who is chairing our Organization Committee. We were very happy
 to welcome these very capable individuals to our board, where they are already making solid
 contributions in a very short period of time.
- We held two business planning seminars for local residents and potential business owners.
 Representatives from Rural Nevada Development Corporation and the Southwest Central
 Regional Economic Development Corporation provided detailed information on how their organizations could assist business start-ups or expansions, help potential business owners write a business plan, and how they could obtain funding. The sessions were well-attended and resulted in one business applying for a loan through RNDC and several calls for information to SWCREDA.
- We are working with Caitlyn Galvin Jones, a Reno realtor, to market the vacant buildings on Main Street.
- We showed the building at 115 Main Street (the old gun shop) to two different potential buyers, and the old Wolfe's Desert Hardware store to one potential buyer. We continue to sell items out of this building to provide additional funding to the Main Street Program.
- Building on the success of Friends of the Belmont Courthouse, we are going to sell wooden Cat's
 Meow Village models of iconic buildings on Main Street. We will call our campaign "It Takes a
 Village to Build a Main Street". The Clines very generously offered to fund this campaign, so
 every model we sell, at \$20 each, represents 100% profit to us. We are attempting to develop
 another passive fundraiser involving several of the downtown businesses and will share
 information with the board when this is finalized.
- We held a multi-hour planning meeting recently and established the following goals for the next year:
 - 1. Obtain sustained funding of \$25,000 to match the town's commitment;
 - 2. Recruit 25 additional investors (we are currently at 12);
 - 3. Implement \$25,000 worth of visual improvements on Main Street;
 - 4. Purchase a sound system for events held on Main Street;
 - Enhance at least one additional vacant storefront;
 - 6. Assist local development agencies in filling one storefront vacancy; and
 - 7. Add at least one mural or monument to our inventory.

Our next meeting will be held at 5:15 p.m. on Wednesday, September 2.

5. <u>Discussion</u>, deliberation and possible decision to adopt, amend and adopt, or reject Tonopah Town Resolution No. 2020-02: A resolution by the Tonopah Town Board expressing their support for the creation of a site honoring the Lockheed F-117 Nighthawk Discussion of possible location; behind the old courthouse. Property belongs to Tonopah resident Vikki Beko.

Ms. Eastley with TMS stated that 10 years ago the cost was close to \$100,000 to get a plane here

Member Downing motioned to adopt Tonopah Town Resolution No. 2020-02: A resolution by the Tonopah Town Board expressing their support for the creation of a site honoring the Lockheed F-117 Nighthawk.

Clerk Grigory seconded.

No further discussion. Motion carried 5-0.

Vice Chairman Elliston suggested someone contact Lockheed to see if they would be willing to help with this project.
