#### Since your last meeting:

- We are still advertising the Project Coordinator's position. We have received one application
  and forwarded application packages to two other individuals. This position will remain open
  until it is filled and in the meantime, various board members have assumed responsibility for
  functions of the Project Coordinator.
- We are still selling items out of the old Wolfe's Desert Hardware store and have made several hundred dollars for the organization.
- At our last meeting held Wednesday, September 2, the board of directors took the following actions:
  - Approved the lease agreement for the newly-refurbished billboard at Montgomery Pass.
     Each side will be leased for \$250 per month. Our next agenda will contain an item to consider leasing our downtown billboard next to the Masonic building for \$125 a month—but not for commercial advertising.
  - The updated job description for the Project Coordinator was approved and advertising started the following day on the Tonopah Main Street Facebook page, on our website, and through posters hung around town.
  - A very generous offer was made by a local business owner for free office space. We are exploring this opportunity and discussing the pros and cons, but no decision has been made.
  - We eliminated the tiered investor rates in favor of a flat fee. The final decision will be made at the next meeting when we approve the updated brochure.
  - Six additional park benches have been received and will be placed at various locations downtown. Two locations have been selected—in front of the post office and A Bar L. Placement discussions with other business owners will take place soon.
  - 6. We are notifying business owners via hand-delivered flyers about the two grant opportunities being offered by Nye County.

Our next meeting will be held at 5:15 p.m. on Thursday, September 24 at the Tonopah Convention Center.
