Future Fence started on Jim Butler Basketball Court. Planning on coming back this week. Baseball team could not get scoreboard to work. AC/DC troubleshot, motherboard is out and is no longer being manufactured. Take the one from field 1 and see if that will work.

Upgrade scoreboards? Possible future project.

Mike Sain may assist with moving motherboard.

\$3,500 for current scoreboard. Chairman Kaminski suggested using the money intended for the reader board. Upgrade 3 scoreboards and ask sponsors to purchase and we put their name on the boards. Sunday night a call about overflowing manhole behind Harvey park, it is flowing again.

Member Downing stated he will not attend next meeting.

Mural update from Tourism and Events Coordinator Kat Galli. Community participation to paint the background stars. To be protected by a clear coat.

Chairman Kaminski inquired; small dedication to the town and people for the mural. This is to be performed during street dance.

Joni Eastley of Tonopah Main Street with updates:

Proposals for grant funding projects from Nevada Main Street Program

Metal artwork on handrails in front of Jim Butler Hotel and the Ramona. These are no parking areas and the artwork will not be covered up.

Concept for the handrails: Cowboys, 18 head of cattle, and a cow dog. Twisted steel estimate; \$28,000 for both sites. Grants will be decided and granted by next Monday.

Grant request is due Friday.
