### 1. Public Comment

Ed Kelly Nye Communities Coalition. WEX and OJT. Thank you for the relationship with the Town of Tonopah.

Shannon Stringer addressed the Board:

Hello,

My name is Shannon Stringer. This past Sunday, May 22 my daughter was competing in the Jim Butler Day's pageant when my husband received a text message from a friend who came by our home, that our dog had been attacked. Upon arriving home we discovered our sweet little lady had been viciously mauled by another dog. It was clear the attack happened in our yard, at my front door. The entire patio was covered in blood. My husband rushed her to the vet in Bishop and she received countless stiches. She has severe wounds to her head, where the entire right side of her face including her ear where nearly ripped from her body and drains in a massive wound under her right leg where she was pulled back after she tried to get away. The fact that this happened at my front door where she was only trying to get to safety breaks my heart. Her entire body is covered in bites. The only way I can imagine she survived is she simply played dead.

The dog who did this was located the following morning, covered in her blood, and ultimately surrendered to Animal Control. I was contacted by animal control on Tuesday morning and assured that the dog was "taken care of and would no longer be a problem". Today, Wednesday May 25, I saw her picture posted on facebook, that said "There are some nice dogs at our shelter" indicating she was available for adoption. I immediately placed a call to find out who I could contact, as I was shocked, that this was possible. I was under the impression the dog was euthanized. I was given a phone number for "TK" Thomas Klenzar, who is the Lieutenant for Nye County Animal Control. I called him and explained the situation, and was told that the dog will absolutely not be euthanized, it WILL be adopted out and "If it's adopted out 10 streets over from me what difference would it make?" I am here to tell you it would make a huge difference to me, constantly being in fear of this vicious dog, who without one shadow of a doubt would be back to the previous owners the first chance it got. This attack was not simply a dog fight where my dog was bitten once or twice and fought. My dog was mauled in my yard and left for dead. The fact that this could have been my child, or anyone else's does not escape me.

Today I learned that Nye County cannot euthanize ANY animal, because they do not hold a license from the DEA to carry the drug, nor do they have anyone with the credentialing to do so. This is contrary to the information provided on the website that states: "Animals that pose a danger to people and/or other animals are humanely euthanized to prevent harm to the residents of our community."

I come to the town today to ask you to please investigate this matter for the safety and well being of our town. I will be speaking at the next county commissioners meeting as well, and I believe if I have the support of the Tonopah Town Board changes will be made. I am asking for there to be criteria that does not allow for a vicious animal to be adopted into our community. This is my home, this is where I raise my family, and this is where I will advocate for this community.
