5. **Discussion, deliberation, and possible action to make a decision regarding Tonopah Town Ordinance Chapter 22.04, Business License Tax and Regulations, Articles I, II, and III for all businesses other than hotels and motels**

Discussion: Rebecca Braska, Kat Galli and the Board. Ms. Braska stated there is no way to enforce the ordinance. Ms. Galli does not support the ordinance, stating not having to obtain a town business license is an attractive feature for businesses. Businesses still need to comply with state requirements. If there are any issues with the businesses, they can be reported to the state. Ms. Braska pointed out that the process is labor intensive. Chair Kaminski suggested an indefinite moratorium. Ms. Galli stated that Steve Gross advised against that, they shouldn't pick and choose ordinances to enforce. The Town should rewrite the ordinance or eliminate it. Hotels and motels receive business licenses due to the room tax ordinance. Motion to approve suspending Tonopah Town Ordinance Chapter 22.04, Business License Tax and Regulations, Articles I, II, and III for all businesses other than transient lodging facilities made by Vice Chair Eastley and seconded by Clerk Grigory. No further discussion and motion carried 3-0.




